## **Ribbons and Awards**

Ribbons will be awarded to 6<sup>th</sup> place. There will be a Champion and Reserve Champion for each division.

For our Gold Show and new for our Silver Show - only one Champion and Reserve Champion will be awarded per division (i.e. Training Level Division will include Test 1 and Test 2).

If entries allow, Champion and Reserve "may" be separated for Junior, Adult Amateur and Open.

Training through Second Level may have awards for categories depending on number of entries. Third and Fourth Level will all be Open category.

Ribbons **MUST** be picked up the weekend of the show (unless arrangements are made for pickup within one week of the show date). Ribbons, prizes and awards will not be held after that.

A High Point Freestyle Award will be given at the end of each show. An overall High Point Award will be given at the end of each show.

Cadora Training Level Freestyle is not eligible for EC Championship or High Point awards.

## **Rules and Regulations**

1. Every class offered herein is covered by the rules and specifications of the current rules of Equestrian Canada (EC) and will be held and judged in accordance with the EC Rule Book. All competitors are responsible for the knowledge of these rules. The show committee reserves the right to govern all conditions of the show. Questions not covered by these rules shall be decided by the show committee and steward and their decisions will be final. The show committee further reserves the right to cancel or change any class and to limit entries.
2. The Dressage at Dewmont competition is sanctioned as a Silver and Gold competition member of Equestrian Canada, 100 – 308 Leggett Drive., Ottawa, Ontario, K2K 1Y6 and is governed in accordance with the EC Rule Book. All entries are required to hold an EC Horse Recording and paid the annual activation fee to compete. Foreign entries must sign an Affidavit (general rule A404). Passports must be handed to the show secretary before horses will be allowed to compete.
3. Riders and Owners are required to be members of the OEF or other PSO. In addition, a minimum of EC Silver Competitive License is required for both Owners and Riders for the Silver show and a minimum of EC GOLD Competitive License is required for both Owners and Riders for the GOLD show. You may contact the OEF for an application form.
4. All athletes, regardless of age or level of competition must wear properly filled and fastened approved protective head gear at all times when mounted at any EC-sanctioned dressage competition at the event location (E.4.0.)
5. Any horse entered in any class at a competition, while on the competition grounds, may be selected for equine medication control testing.
6. A copy of a current negative Coggins Test for each horse entered **MUST** accompany entries.
7. Horses may compete in a maximum of 4 technical tests in one day at 2 consecutive levels, including the corresponding Freestyle Class.
8. Competitors must wear their competition number at all times on the show grounds.

9. Competitors must have achieved 55% in one technical test at the appropriate level, either at a previous show or the current show, to be eligible to enter a freestyle class. Under Dressage Rule E10.3.4, please provide TWO (2) functioning copies of your Freestyle music that can be played on a CD player and not a computer or tape machine.
10. No Hors Concours entries will be accepted.
11. No lunging in warm-up area.
12. NSF cheques will be charged a \$40 admin fee and will be reported to Equestrian Canada.

## Equestrian Canada Statement of Principle

Equestrian Canada (EC), the National Federation of Canada, supports adherence to humane treatment of horses in all competitions under its jurisdiction. EC is committed to:

- Upholding the welfare of horses, regardless of value, as a primary consideration in all activities.
- Requiring that horses be treated with kindness, respect, and the compassion that they deserve, and that they never be subjected to mistreatment.
- Ensuring that owners, trainers, exhibitors, and their agents use responsible care in handling, treatment, and transportation of their horses as well as horses placed in their care for any purpose.
- Providing for the continuous well-being of horses by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort, sanitation and safety as a matter of standard operating procedure.
- Continuing to support scientific studies on equine health and welfare.
- Increasing education in training and horsemanship practices.
- Requiring owners, trainers, and exhibitors to know and follow their sanctioning organization's rules and to work within industry regulations in all equestrian competitions.
- Reviewing, revising, and developing competition rules and regulations that protect the welfare of horses.
- Per Article A801, every entry at an EC sanctioned competition shall constitute an agreement by the person responsible that the owner, coach, agent, driver, lessee, manager, driver, rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition.
- Every entry shall further constitute an undertaking that:
  - a) every horse, rider or driver is eligible as entered; and
  - b) the owners, lessees and any of their representatives agree to be bound by the constitution and rules of Equestrian Canada and the competition, to accept as final the decision of the EC Board of Directors on any question arising under said rules, and agree to hold the competition, EC, their officials, directors and employees harmless for any action.
- Entry forms must be properly completed as they supply the information required to credit points won at EC competitions for awards and for qualification to specific EC competitions which require this information.
- All entries must be made in writing and must be accompanied by funds to cover all expenses involved, including entry and stabling fees and other applicable charges. However, a competition has the option to state in their prize list that they will accept entries by fax. Any competitor or agent who provides payment which is ultimately non-negotiable is in violation of these rules.
- No Entry is eligible to compete until the entry forms has been signed by the person responsible (please see Glossary for definition of "Person Responsible"). A parent (or guardian) must sign for junior riders/drivers. It is the responsibility of the competition secretary to ensure that no entry competes until or unless this requirement is met.
- Person Responsible (PR) must sign the competition entry form.

- PR must be an EC Sport License holder in good standing OR in the case of junior/minor owner entries, a parent/guardian is entitled to sign as PR. In the case of USEF member entries PR may also be a USEF member in good standing (see Article A2013.2).
- The standard by which conduct or treatment will be measured is that which a reasonable person, informed and experienced in generally accepted equine training and exhibition procedures, would determine to be neither cruel, abusive, nor inhumane.

## **Entry Requirements**

**All entries are to be input using the Showmate software; access at [www.dewmontfarms.ca](http://www.dewmontfarms.ca)**

Please have available a copy of your EC/PSO, current coggins, or receipt of purchase of PSO and EC for perusal by the steward. These are NOT REQUIRED by the show office.

Payment in full is due by June 18, 2018. Cheque or e-transfer are accepted. No Cash and No postdated cheques. If payment is not made by June 18, the competitor will not be allowed to compete.
